A caregiver shall remain in the room with preschool and school-age children while they are napping or sleeping and shall be able to see and hear them if they have difficulty during napping or when they awaken.

19 CSR 30-62.112 (1)(A)

Birth Through Two (2) Years. Groups composed of mixed ages through two (2)- years shall have no less than one (1) adult to four (4) children, with no more than eight (8) children in a group.

19 CSR 30-62.112 (1)(E)

Mixed Age Groups Two Years (2) and Up. Groups composed of mixed ages of children two (2) years of age and older shall have no less than one (1) adult to ten (10) children with a maximum of four (4) two (2)-year olds. When there are more than four (4) two (2)-year olds in a mixed group, the staff/child ratio shall be no less than one (1) adult to eight (8) children.

CONCLUSION SUMMARY

The Section for Childcare Regulation has determined that Mercy Childcare Center L.L.C violated child care licensing rules related to staff/child ratios. On April 8, 2019, CCFS Michelle Ruffin conducted an unannounced inspection and observed nine (9) infants with three (3) caregivers in one of the infant/toddler rooms and four (4) infants and one (1) caregiver in the second infant/toddler room. The maximum group size allowed in the infant/toddler unit is eight (8) children. In the preschool classrooms, CCFS Ruffin observed a caregiver sitting between two classrooms watching both rooms of children during naptime while a second caregiver was downstairs on break.
