CONCLUSION SUMMARY

On January 17, 2023, the Office of Childhood (OOC) received an allegation that: On 1/16/23 at about 8:30 or 9:00am, Arianna Johnson was brought into the classroom of her own child, Child A (dob 7/26/17), because he was misbehaving. She then "popped" him in the mouth. After conducting an investigation, Compliance Inspector (CI) Michelle Honea has found this allegation to be substantiated based on the following evidence:

5 CSR 25-500.182(1)(C)7., which states the following: "Physical punishment including, but not limited to, spanking, slapping, shaking, biting, or pulling hair shall be prohibited."

AND

5 CSR 25-500.182(1)(C)3., "Only constructive, age-appropriate methods of discipline shall be used to help children develop self-control and assume responsibility for their own actions."

On January 18, 2023, Compliance Inspector (CI) Michelle Honea conducted an unannounced inspection at the facility and interviewed Sharon Sweezy, Johnna Logue, teacher Caitlin Hammond, and teacher Laurie Dyer who all stated that on January 16, 2023, Parent A(parent of Child A and also a caregiver at the facility), "popped" Child A in the face once and then in the mouth once for cursing in the classroom. Parent A was terminated immediately.

CI Honea observed the video of Parent A coming into the room, then popping Child A on the cheek, then picked up Child A, and then popped Child A on the mouth. Parent A then took Child A to the bench to sit down. CI Honea also observed the written statements about the incident, other incident reports, Child A's enrollment form, and Parent A's application for employment.
