CONCLUSION SUMMARY

Office of Childhood has determined that St. John's Evangelical Lutheran Church of Hannibal, Missouri, has violated rules regarding staff child ratio based on the statements of staff Michaela Hull, Danielle Gallup, and Marilyn Sublette. Specifically:

Michaela Hull stated:

- -She has definitely been over her correct number of children in the past.
- -It is usually afterschool with the older children.
- -She has had up to 28 kids in her care by herself in the gym before.
- -This has happened a couple times.
- -The last time she had too many kids was December 1, 2021, which were age range Kindergarten through 8th grade.
- -When this happens, it usually happens for approximately one hour from 3:00 p.m. to later.
- -There is no other staff with her sometimes until she goes to the preschool playground about 4:00 p.m.

Danielle Gallup stated:

- -There has been multiple times that the school-age children and teachers are out of ratio.
- -The last time it happened has been within the last two weeks.
- -There was one teacher to approximately 25 children.

Marilyn stated:

- -"We are taking care of it"
- -"It is being taken care of"
- -"That is all I am going have to say"

CI Duckworth asked Marilyn Sublette if the child/staff ratio concerns that "are being taken care of" are with the preschool children and Marilyn stated "yes".
