5 CSR 25-500.082(1)(K)

No person shall smoke or otherwise use tobacco products in any area of the child care facility during the period of time when children cared for under the license are present.

#### **CONCLUSION SUMMARY**

Compliance Inspector (CI) Jessica Glover conducted an investigation regarding the allegation that teachers were vaping indoors in front of children and blowing smoke towards the children. After conducting the investigation, CI Glover finds this allegation is substantiated. This conclusion is based on the following evidence of licensing rule violations which occurred at the facility:

5 CSR 25-500.082(1)(K) which states: "No person shall smoke or otherwise use tobacco products in any area of the childcare facility during the period of time when children cared for under the license are present."

On May 11, 2022, CI Glover interviewed Director Fred Huffman, Assistant Director Faith Cummins and Caregivers Dana Winters, Brailynn Harlan and Teon Cokes whom all stated that staff were allowed to smoke and vape on premises. Mr. Huffman stated that teachers who utilized a smoke break were required to go outside and smoke in a designated area near the playground. Ms. Harland stated she would often times vape inside the staff bathroom throughout the day as well. Even though none of the staff admitted to blowing smoke in the direction of the children, CI Glover determined that staff were smoking and using tobacco products in the area of the childcare facility during childcare hours, while children were present.
