CONCLUSION SUMMARY

Section for Child Care Regulation determined that licensing rules were violated on February 21, 2020, based on observations made by CCFS Amy Banning. CCFS Banning observed nine children in the infant/toddler room with two caregivers. Staff-to-child ratio for infant/toddler is one staff to every four children. Based on the observations there was sufficient evidence that licensing rules were violated.
