19 CSR 30-62.192 (4)(B)

A child who has not completed all immunizations appropriate for his/her age may enroll, if.

19 CSR 30-62.192 (4)(B)(2)

The parent(s) or guardian has signed and placed on file with the day care administrator a statement of exemption which may be either of the following.

19 CSR 30-62.192 (4)(B)(2)(B)

A parent or guardian exemption, by which a child shall be exempted from immunization requirements if one (1) parent or guardian files a written objection to immunization with the day care administrator. Exemptions shall be accepted by the day care administrator when the necessary information as determined by the department is filed with the day care administrator by the parent or guardian. Exemption forms shall be provided by the department (see 19 CSR 40-61.185).

CONCLUSION SUMMARY

The Section for Child Care Regulation has determined this allegation of a rule violation to be substantiated based upon Child Care Facility Specialist Ronda Tuschhoff's interview and observation:

On September 23, 2020, Child Care Facility Specialist Ronda Tuschhoff heard Caregiver Tonya Maggard state that The Parent of Child A did not believe in immunizing Child A (age 6 years). In addition, Child Care Facility Specialist Ronda Tuschhoff observed that Child A did not have any immunization records on file. Continuing, Child A had a religious immunization exemption on file instead of the parent immunization exemption. In addition, the religious immunization exemption did not identify which immunizations Child A was exempt from.
