### **RULE/STATUTE VIOLATION(S)**

#### VIOLATION(S)

5 CSR 25-500.112(1)

The following staff/child ratios shall be maintained on the premises at all times:

5 CSR 25-500.112(1)(E)

Mixed Age Groups Two Years (2) and Up. Groups composed of mixed ages of children two (2) years of age and older shall have no less than one (1) adult to ten (10) children with a maximum of four (4) two (2) -year olds. When there are more than four (4) two (2) -year olds in a mixed group, the staff/child ratio shall be no less than one (1) adult to eight (8) children.

#### **CONCLUSION SUMMARY**

Compliance Inspector (CI) Stephanie Spaulding investigated the allegation that ratios are always out and over by one or two kids. The allegation was substantiated based on the following information:

5 CSR 25-500.112(1) which states: "The following staff/child ratios shall be maintained on the premises at all times:" AND

5 CSR 25-500.112(1)(E) which states: "Mixed Age Groups Two Years (2) and Up. Groups composed of mixed ages of children two (2) years of age and older shall have no less than one (1) adult to ten (10) children with a maximum of four (4) two (2) -year olds. When there are more than four (4) two (2) -year olds in a mixed group, the staff/child ratio shall be no less than one (1) adult to eight (8) children."

On September 20, 2022, CI Spaulding conducted a walkthrough to observe and document attendance and staff/child ratios. Violations were observed in that eleven children, three 2-years-old and eight 3- to 4-years-old, with one caregiver.
