CONCLUSION SUMMARY

Section for Child Care Regulations has determined Emmanuel Family and Child Development Center and Emergency Shelter for Children violated licensing rule 19 CSR 30-62.182 (1)(C)(3). There is not enough evidence to indicate the bruise was caused by a caregiver. However, the video shows two staff having inappropriate physical interactions with children. Ms. Markell Jones grabs a child by the arm (twice) and Ms. Helen Hill grabs a child by the hand and moves him toward a bookshelf. The boy is not walking but is being drug. As part of the complaint children were interviewed, A child reported witnessing staff grabbing two children by the arm and another child reported the staff grabbed her arm for being in trouble and it hurt her arms. Based on the information gathered during the investigation the allegation is substantiated.
