## **CONCLUSION SUMMARY**

The Office of Childhood, Child Care Regulations has determined that this allegation is substantiated based on interviews with Timothy Fugitt, Jenifer Dalberg, Shavonne Fields and observations made by CI Crystal Heiser.

5 CSR 25-500.112 (1) (C) Ages Three through Four (3-4) Years. Groups composed solely of three (3) ? and four (4) shall have no less than one (1) adult to ten (10) children.

Timothy Fugitt did not recall being out of ratio except for over by one student and they went outside to maintain ratio until another teacher arrived to assist. Timothy did not recall who stepped in to help but thought it was either Sabrina Bratton or Shavonne Fields. Sabrina Bratton could not be reached for interview. Shavonne fields could not recall stepping in or any classroom being out of ratio.

Based on observations of the name-to-face transitions records the Pre-k classroom was out of ratio. It is documented that at 9:10 am caregiver, Timothy Fugitt had 17 children going outside and at 10:10 am coming inside from the playground Timothy Fugitt had 19 children. The record also shows that while inside prior to going to the playground at 9:05 am Timothy Fugitt had 16 children. The record shows that at 11:05 am and at 1:06 pm there was one staff, Timothy Fugitt to 19 children.

According to the name-to-face transitions records the 3's classroom on August 25, 2021 shows that there was one staff, Debra Hendricks with 13 children during naptime at 12:45 pm and also at 2:00 pm.
