All medication shall be given to a child only with the dated, written permission of the parent(s) stating the length of time medication may be given.

CONCLUSION SUMMARY

Section for Child Care Regulation has determined that Creative World School, Inc. violated licensing rules. CCFS Jill Zeigenbein conducted interviews with cook Ronni Sparks, co-director Kaylee Cassidy, and caregivers Shannon Nevels and Lindsey Ritter. During these interviews all stated that they were aware that Child A was allergic to eggs and that he was served French toast on November 18, 2019. Further, these rules were violated based on CCFS Jill Zeigenbein's observation that there was not a Specialized Care Plan in Child A's file to inform the staff about Child A's allergy nor was there an infant diet plan stating what specifically Child A could eat, and based on Child A's mom's statement that she has not been asked to complete a Specialized Care Plan on Child A.

Further, this report is substantiated based on Child A's mother's statement that the daycare has Benedryl at the daycare for Child A and CCFS Zeigenbein's observation that there was not an authorization on file from Child A's parents authorizing Child A to be administered the Benedryl.

CORRECTIVE MEASURES

CORRECTIVE MEASURE

Creative World School, Inc. will ensure that all children with any special health care needs have a Specialized Care Plan completed by a medical professional on file. The facility will review all children's files for child who have special health care needs, make sure a Specialized Care Plan is on file for the child and document the completion of the review. This documentation will remain on file at the facility for review by a specialist at future inspections.
