19 CSR 30-62.182 (1)(C)(3)

Only constructive, age-appropriate methods of discipline shall be used to help children develop self-control and assume responsibility for their own actions.

19 CSR 30-62.182 (1)(C)(7)

Physical punishment including, but not limited to, spanking, slapping, shaking, biting or pulling hair shall be prohibited.

19 CSR 30-62.222 (3)(C)

Information concerning any accident or injury to the child while at the facility or any emergency medical care.

# **CONCLUSION SUMMARY**

This investigation is substantiated based on interviews with staff and observations made by CCFS Alison Evans. During the investigation interviews were completed with Owner, Britany Hopkins Director, Britany Moore, and Staff, Monica Nyman. Interviews were also completed with Child A's mother. Through the interviews it was determined that Staff, Monica Nyman did in fact use physical punishment to include lifting Child A by the arm inappropriately and holding Child A down while strapped in a time out chair. This type of discipline was not constructive, age-appropriate methods of discipline to help children of this age develop self-control and assume responsibility for their own actions. Based on the interviews on March 5 and March 26, 2020, video footage and no incident report completed is found that the said allegation is substantiated.
