Caregivers shall provide frequent, direct contact so children are not left unobserved on the premises.

CONCLUSION SUMMARY

Based on the information obtained during the interviews with caregivers and children who attend the Missouri Southern State University Lion Cub Academy, Joplin, Missouri, CCFS Hohensee determined children were playing in areas where caregivers were not observing them on more than one occasion. All caregivers denied seeing or knowing about the inappropriate behaviors until June 14, 2019 through June 17, 2019; however, Children B, C and D reported the inappropriate behavior occurred and that they hid on the playground so caregivers could not see them. Caregivers Cindy Teem and Celeste Tarrant spoke to the children involved in the inappropriate "private game" and all three children admitted to doing this at the center and caregivers failed to provide the supervision necessary to prevent the children from playing the "private game".
