# **RULE/STATUTE VIOLATION(S)**

## VIOLATION(S)

19 CSR 30-62.082 (6)

Outdoor Space.

19 CSR 30-62.082 (6)(B)

Infants and Toddlers.

19 CSR 30-62.082 (6)(B)(2)

Staff/child ratios for infant/toddlers and two (2)-year olds shall be maintained at all times.

19 CSR 30-62.112 (1)

The following staff/child ratios shall be maintained on the premises at all times.

19 CSR 30-62.112 (1)(A)

Birth Through Two (2) Years. Groups composed of mixed ages through two (2)- years shall have no less than one (1) adult to four (4) children, with no more than eight (8) children in a group.

19 CSR 30-62.112 (1)(E)

Mixed Age Groups Two Years (2) and Up. Groups composed of mixed ages of children two (2) years of age and older shall have no less than one (1) adult to ten (10) children with a maximum of four (4) two (2)-year olds. When there are more than four (4) two (2)-year olds in a mixed group, the staff/child ratio shall be no less than one (1) adult to eight (8) children.

## **CONCLUSION SUMMARY**

SCCR determined that Lots of Love Preschool Childcare Center violated the above licensing rules based on the statement of caregiver Kobe Brown, that he had 21 children, ages 2 through 9 years old, on the playground on June 13, 2017 by himself along with a statement from former caregiver Kay Otterbourg who stated that she was the only caregiver responsible for 23 children, ages 2 through 9, on June 13, 2017. She stated that she left the facility and did not return to work. Facility owner Kim Jones stated that on June 13, 2017, a staff member walked out of the facility and did not return which resulted in them being short-handed. Facility director Jenn Hartley, stated the facility is continuously out of ratio due to being short-staffed. In addition, Child Care Facility Specialist Cynthia Maddox and Child Care Supervisor Christina Bruce observed 21 children, ages 2 through 9 years old, on the playground with only two caregivers and 5 infant/toddlers with one caregiver on June 20, 2017.

## VIOLATION(S)

19 CSR 30-62.202 (1)(A)

The provider shall supply and serve nourishing food according to the Meal and Snack Food Chart provided in this rule.

#### **CONCLUSION SUMMARY**

SCCR determined that Lots of Love Preschool Childcare Center violated the above licensing rule based on the statement by facility cook Mattie Houston who stated that she does not measure the snack for the children. Facility director Jenn Hartley stated that the children sometimes only get a sandwich and one carrot stick for lunch, the facility often runs out of supplies including food and there have been times when children were fed just a graham cracker and no drinks for snack. In addition, Child Care Facility Specialist Cynthia Maddox and Child Care Supervisor Christina Bruce observed a limited amount of food in the kitchen that would be insufficient for 40 children.

## VIOLATION(S)

## 19 CSR 30-62.202 (1)(I)

State or local rules, or both, governing food service sanitation shall be maintained in the storage, preparation and service of foods.

#### **CONCLUSION SUMMARY**

SCCR determined that Lots of Love Preschool Childcare Center violated the above licensing rule based on the statement of facility cook Mattie Houston who stated that she does take snack to the classrooms at lunch time and statements from caregiver Kobe Brown and caregiver Jenn Hartley that there are times when the snack, brought to the classrooms at lunch time, needed to be refrigerated and the food was left out until the children ate snack. Former caregiver Kay Otterbourg stated that snack was brought to her class at lunch and sometimes it was yogurt, pudding, or cottage cheese and it sat there for almost three hours until the children awoke from their from nap.

#### VIOLATION(S)

#### 19 CSR 30-62.082 (6)(A)(1)

A fenced outdoor play area shall be available on or adjoining the day care property. The play area shall be located so it is convenient and the children can gain access to it without hazard. For facilities initially licensed after the effective date of these rules or for the installation of new fences in existing facilities, the fence shall be at least fortytwo inches (42") high. An outdoor play area used exclusively for school-age children shall not be required to have a fence. Fences shall be constructed to prevent children from crawling or falling through or becoming entrapped.

#### **CONCLUSION SUMMARY**

SCCR determined that Lots of Love Preschool Childcare Center violated the above licensing rule based on the observations made by Child Care Facility Specialist Cynthia Maddox and Child Care Supervisor Christina Bruce on June 20, 2017 of the wooden fence surrounding the playground. The fence had three loose boards and one broken board that had a sharp point and a gap approximately 4 1/2 inches wide on side facing Oakland Gravel Road.
