CONCLUSION SUMMARY

Child Care Facility Specialist (CCFS) Jasmine Cooley conducted an investigation regarding the allegation that the facility is signing kids in when they are not in attendance. After conducting the investigation, CCFS Cooley finds this allegation to be substantiated. This conclusion is based on the following evidence.

19 CSR 30-62.222 (1) "The child care provider shall maintain accurate records to meet administrative requirements and to ensure knowledge of the individual needs of children and their families."

Charley's Angels LLC has provided an attendance log for the month of January 2019. On January 15-17, 2019 Child A is signed in to the facility. In addition, Kimberly Nott, Program Development Specialist with the Department of Social Services indicated that child care subsidy was paid for Child A, January 14-18, 2019. Although LLC Managing Members Althea and Todd Alexander stated that they do not sign any child in attendance who is not here at the facility, the hospital discharge summary, provided by Parent of Child A, shows Child A being admitted into the hospital from January 14, 2019 and discharged on January 18, 2019.
