19 CSR 30-62.182 (1)(C)(7)

Physical punishment including, but not limited to, spanking, slapping, shaking, biting or pulling hair shall be prohibited.

#### **CONCLUSION SUMMARY**

On May 28,2021 a complaint was received by the Section For Child Care Regulation that child had been "popped" by a teacher. On June 02, 2021 Child Care Facility Specialist Gregg Gillen arrived at the facility unannounced. Gillen conducted an investigation and interview of several staff members at the facility. On June 02, 2021 Gillen also conducted a phone interview of the parent that witnessed the incident. On June 03, 2021 Gillen conducted a phone interview of the mother of Child A. After conducting the investigation it has been determined that the allegation is substantiated.

The conclusion is based on the following evidence of a violation of:

19 CSR 30-62.182 (1)(C)(7) Physical punishment including, but not limited to, spanking, slapping, shaking, biting or pulling hair shall be prohibited.

It was determined from the statements given during the interviews I conducted, by the witnesses that were in the room at the time of the incident, that Karima Kuol did hit Child A on the arm and leave a small red mark. It was determined that Karima did this out of frustration that Child A had soiled herself and that Child A would not stop hitting Karima when Karima asked Child A to stop.
