CONCLUSION SUMMARY

Based on the investigation, Section for Child Care Regulations determined All about Kids Learning Center violated the licensing rule above.

On April 28, 2021, the reporter stated Child A had bruises all over Child A's legs and never receive any accident reports. On May 5, 2021, Child Care Facility Specialist Madeline Dumercy conducted an unannounced inspection at All about Kids Learning Center and interviewed Director Jaime Shipp. Colleen stated that she recalls the time Child A fell in the playground and the caregivers showed her the bruise that was forming. She immediately informed Parent A, also a caregiver at the facility and parent of Child A, about Child A's injury but did not write an accident report for the injury. On May 5, 2021, Child Care Facility Specialist Madeline Dumercy observed Child A's incident reports and did not see an incident for April 5, 2021.

Based on interview, there is sufficient evidence the complaint is substantiated.

VIOLATION(S)

19 CSR 30-62.082 (2)(B)(2)(B)(III)

If a unit for infants and toddlers is auxiliary to a facility for older children, centers initially licensed for infant/toddler care after the effective date of these rules or facilities adding new infant/toddler space, shall have play, sleeping and bathroom space in the infant and toddler unit. This space shall be separated from the space used for older children by floor-to-ceiling walls.

CONCLUSION SUMMARY

Based on the investigation, Section for Child Care Regulations determined All about Kids Learning Center violated the licensing rule above.

On April 28, 2021, the reporter stated Child B and Child C are not two years old and were sent over to the two years old room. On May 5, 2021, Child Care Facility Specialists conducted an unannounced inspection at All about Kids Learning Center and interviewed Director Jaime Shipp. Jaime she was informed by a specialist that she was allowed to move children from infant/toddler unit a week before their birthdate to the two year old room. Also, once the children have been moved up they cannot move down. Jaime stated that both children started in the two year old room before their second birthday. Based on interview, there is sufficient evidence the complaint is substantiated.
