Information regarding the date and circumstance of any accident or injury shall be noted in the child's record.

CONCLUSION SUMMARY

Section for Child Care Regulation (SCCR) has determined that Rising Sun Learning Center violated licensing rules when on May 30, 2019 Child A's mother did not receive an incident report. The allegation that Child A was bitten by another child on May 30, 2019 and Child A's mother did not receive an incident report is substantiated due to evidence obtained from interviews and a review of documents in Child A's file.

CCFS Ferro conducted an unannounced inspection on June 10, 2019 and interviewed Administrative Assistant Jessica Tran, and caregivers Keke Pickett, Biliha Breakfield, and Breunna Greer. Child A's mother and facility director, Megan Huffman were also interviewed by telephone.

Child A's mother stated Child A had been bitten seven (7) times since transitioning to the toddler classroom. The latest incident of biting occurred on May 30, 2019 and she did not receive an incident report.

Child A's caregivers, Keke Pickett and Breunna Greer stated Child A was bitten late on the playground late in the day on May 30, 2019. They stated they forgot to write a report and each assumed the other, or the caregiver from Treehouse, Biliha Breakfield, who cared for the biter, had written the report. Therefore, Child A's mother did not receive an incident report for a bite her child received on May 30, 2019.

Staff indicated they do not notify parents when children are bitten unless the skin is broken. It is the responsibility of Rising Sun Learning Center to notify the parent anytime a child has an accident or injury.
