### **RULE/STATUTE VIOLATION(S)**

#### VIOLATION(S)

19 CSR 30-61.175 (1)(A)(1)

Child care providers shall not leave any child without competent adult supervision.

19 CSR 30-61.175 (1)(A)(3)

Caregivers shall provide frequent, direct contact so children are not routinely left unobserved on the premises.

19 CSR 30-61.155 (1)

There may be situations (for example, to accommodate parent's work shifts or before and after-school care) when the number of children in care over two (2) years of age may exceed the licensed capacity of the home. The number in care shall never be more than one third (1/3) over the licensed capacity of the home at the time of overlap. The overlap period(s) shall not exceed two (2) hours total in any twenty-four (24)-hour child-care day. The two (2) hours of available overlap time may be utilized in smaller time periods.

#### **CONCLUSION SUMMARY**

SCCR determined the allegations to be substantiated based on an unannounced inspection made to the Karen Hopkins home by CCFS Zeigenbein on January 10, 2018 to initiate this investigation. During the investigation CCFS Jill Zeigenbein observed two (2) children playing downstairs unsupervised. All children must be on the same level of a home with the childcare provider to ensure safety and supervision of the children. Also, during the investigation Jill Zeigenbein observed Karen Hopkins providing care for 15 unrelated children and 1 related child, when the overlap only allows for 13 unrelated children during the overlap times.
