19 CSR 30-62.082 (2)(B)(2)(B)(V)

In facilities initially licensed for infant/toddler care after the effective date of these rules or facilities adding new infant/toddler space, no more than twentyfour (24) infants/toddlers and/or two (2)-year olds shall be in a room. A room shall be defined as an area separated from other parts of the building by floor-to-ceiling walls. Stable partitions a minimum of four feet (4') in height shall be used to separate the infant/toddler or two (2)-year old groups, or both, in a room.

CONCLUSION SUMMARY

This allegation is substantiated based on the following rule violation:

19 CSR 30-62.082 (2)(B)(2)(B)(V) In facilities initially licensed for infant/toddler care after the effective date of these rules or facilities adding new infant/toddler space, no more than twentyfour (24) infants/toddlers and/or two (2)-year olds shall be in a room. A room shall be defined as an area separated from other parts of the building by floor-to-ceiling walls. Stable partitions a minimum of four feet (4') in height shall be used to separate the infant/toddler or two (2)-year old groups, or both, in a room.

Upon arrival to Mind's N Motion Learning Center, LLC on 2/15/2019, Ronna Chilton (owner) and Emily Keenan (director) were gathered in the main preschool room of the facility with 4 Infants and Toddler and 5 Preschool age children. Ronna and Emily both stated that there are times when they will mix all age groups in the early mornings before taking the Infants and Toddlers to their classroom.

The provider shall ensure that the infant and toddler children are cared for in the infant and toddler unit at all times. The child care provider must provide the Section for Child Care Regulation with a statement, signed by all staff and volunteers, to indicate they understand and agree to follow the requirements.
