Center directors and group child care home providers routinely shall be on duty during the hours of highest attendance a minimum of forty (40) hours per week. If the facility operates less than forty (40) hours per week, the center director or group child care home provider shall be on duty at least fifty percent (50%) of the operating hours.

5 CSR 25-500.222(6)

Daily staff and volunteer attendance records shall be maintained and kept on file a minimum of one (1) year.

CONCLUSION SUMMARY

On November 3, 2022 Compliance Inspector (CI) Michelle Trussell conducted an unannounced investigation into the allegation that the facility's approved director is not on site at least 40 hours a week. The allegation is substantiated based on the following:

5 CSR 25-500.102(2)(A)2 states: "Center directors and group child care home providers routinely shall be on duty during the hours of highest attendance a minimum of forty (40) hours per week. If the facility operates less than forty (40) hours per week, the center director or group child care home provider shall be on duty at least fifty percent (50%) of the operating hours."

AND

5 CSR 25-500.222(6) states: "Daily staff and volunteer attendance records shall be maintained and kept on file a minimum of one (1) year."

On November 3, 2022 CI Trussell interviewed A.S. (Staff member), J.K. (Facility named Director), M.G. (Staff member) and I.M. (Staff member). All staff members interviewed admitted A.B. (Director) is not present at the facility 40 hours a week. Furthermore, J.K. (Facility named Director) stated A.B. (Director) works at a different facility this is owned by the same corporation. J.K. (Facility named Director) also stated there were no time cards and/or attendance records for A.B. (Director) to show hours she is at the facility.
