<u>19 CSR 30-62.112 (1)</u>

The following staff/child ratios shall be maintained on the premises at all times.

<u>19 CSR 30-62.112 (1)(A)</u>

Birth Through Two (2) Years. Groups composed of mixed ages through two (2)- years shall have no less than one (1) adult to four (4) children, with no more than eight (8) children in a group.

# CONCLUSION SUMMARY

On June 16, 2021, Compliance Inspector (CI) Jessica Graham investigated the allegation that Parent A picked up Child A from daycare and noticed multiple scratches on her face/ear. Parent A is concerned about neglect and not enough staff. Parent A knows a child scratched Child A, not an adult. This allegation is substantiated based on the following rule violations:

19 CSR 30-62.112 (1) which states: "The following staff/child ratios shall be maintained on the premises at all times:" 19 CSR 30-62.112 (1)(A) which states: "Birth Through Two (2) Years. Groups composed of mixed ages through two (2)- years shall have no less than one (1) adult to four (4) children, with no more than eight (8) children in a group."

On June 16, 2021, CI Graham interviewed Group Home Provider Jarica Green. Ms. Jarica stated that she did not notice any scratches on Child A at all during the day on June 15, 2021. On that day, s. Miranda brought Child A up to her after nap and showed her the scratches on Child A's face. There is usually 7 or 8 children in the room with one caregiver during nap time and the children on that day were ages 1 year to age 4 years.

On June 16, 2021, CI Graham interviewed caregiver Miranda Kirchner. Ms. Miranda stated that she normally has 7 or 8 kids in that room at nap time, but on June 15, 2021, there were only 6 kids. Child A is the youngest napper in the classroom and is hard to get to nap. Child A could have scratched her face with her nails because she wipes her face a lot. Child A constantly touches her face and she
