## **RULE/STATUTE VIOLATION(S)**

### VIOLATION(S)

19 CSR 30-62.182 (1)(A)(1)

Caregivers shall not leave any child without competent adult supervision.

19 CSR 30-62.182 (1)(A)(3)

Caregivers shall provide frequent, direct contact so children are not left unobserved on the premises.

19 CSR 30-62.102 (1)(J)

All staff shall acquaint themselves with the child abuse and neglect law and shall make a report of any suspected child abuse or neglect to the Division of Family Services at the toll free number, 1-800-392-3738.

19 CSR 30-62.222 (4)(C)

Information concerning any accident or injury to the child while at the facility or any emergency medical care.

### **CONCLUSION SUMMARY**

The Section for Child Care Regulation determined Audra Freeman violated the above licensing rules on June 6, 2017 based on statements made by staff members Kiera Thorpe and Cedric Logan that Child E was found alone in the yellow room for approximately ten minutes and Child D was alone in the bluebird room for an unknown amount of time, the statement from Parent D that she found Child E alone in the yellow room and staff did not know where he was, and the statement from Audra Freeman, director, that no staff member or anyone called the Child Abuse and Neglect hotline or wrote an incident report about this incident.
