The provider shall supply and serve nourishing food according to the Meal and Snack Food Chart provided in this rule.

5 CSR 25-500.202(1)(E)

One (1) serving of fluid milk shall be served with each meal.

# CONCLUSION SUMMARY

Compliance Inspector (CI) Stephanie Spaulding conducted an investigation of the allegation that a 2-year-old child was not served milk on May 6, 2022 at breakfast, had to bring the child's lunch and was not given milk, and on May 13, 2022 was given meat, cheese, carrot, cereal, and potato chips. The allegation is substantiated based on the following information:

5 CSR 25-500.202(1)(A) which states: "The provider shall supply and serve nourishing food according to the Meal and Snack Food Chart provided in this rule."

AND

5 CSR 25-500.202(1)(E) which states: "One (1) serving of fluid milk shall be served with each meal."

On May 18, 2022, caregiver Breanna Sheets stated that the children received water with lunch on May 18, 2022. While the children receive milk with breakfast, they only receive water with lunch and snack.

On May 18, 2022, director Brooke Crane stated that there was a child that brought their own lunch because the family was vegan and dairy free. This was a parental preference. She was not aware children couldn't bring their own lunch. It was an error that on May 18, 2022, the Two's children did not receive milk at lunch. On May 13, 2022, the vegetable component may have been missed.

On May 18, 2022, caregiver Justice Howard stated that the Two's children received water with lunch on May 18, 2022.
