### VIOLATION(S)

5 CSR 25-500.182(1)(A)1.

Caregivers shall not leave any child without competent adult supervision.

5 CSR 25-500.182(1)(A)3.

Caregivers shall provide frequent, direct contact so children are not left unobserved on the premises.

## CONCLUSION SUMMARY

The Office of Childhood has determined that North Central Missouri Head Start A has violated the above licensing rules based on the observation of recorded video tape by Compliance Inspector (CI) Ellen Donoho who observed 3 year old Child A alone in the classroom for a period of approximately six (6) minutes with no adult supervision. Further, Administrative staff members, Janet Gott and Tina Marrs also reported having observed the video of Child A left unsupervised for a period of approximately six (6) minutes in a classroom at North Central Missouri Head Start A in Brookfield, MO. Emily Gladbach, lead teacher is observed exiting the building with all the other children in the classroom out the front door, Janessa Gaunt is observed looking at Child A though the front door of the building, but not coming in after Child A.

Substitute teacher Linda Shaw is observed assisting Child A in the hallway with his belongings after he got up from the classroom and came into the hallway by himself. This decision is also based on the statement from Janessa Gaunt. Ms. Gaunt reported that she does not recall staff counting children on that date. Ms. Gaunt also stated that, while the children were waiting for their parents, she saw Child A inside at his cubby and she was talking to him through the door, but she did not come back in because the door was locked. She could see Child A. She did not ask Emily Gladbach for a key to get in. In a few minutes, she saw Linda Shaw helping Child A get his things together to leave.
