The diapering table shall be cleaned thoroughly with a disinfectant after each use.

Caregivers changing diapers shall wash their hands with soap and running water each time after changing a child's diaper.

19 CSR 30-62.082 (2)(A)(9)

The facility shall be clean at all times and free of dirt, insects, spiders, rodents or other pests.

CONCLUSION SUMMARY

Based on observations by CCFS Gina Hohensee and CCFS Melissa Milan, it has been determined that this allegation is substantiated. CCFS Hohensee and CCFS Milan observed a caregiver in the northeast infant classroom changing an infant's diaper the caregiver then started to change another diaper without sanitizing the diaper changing pad and without washing the infants hands or her hands before picking up the second child. In this same infant room, a sheet in one of the cribs was soiled. At approximately 10:30 AM, CFFS Hohensee and CCFS Milan observed floors that needed to be mopped throughout the center and in each classroom. The carpets/rugs in each classroom were also dirty and did not appear to have been recently vacuumed. In the southeast infant /toddler room, dead insects and dust was observed on the window ledge directly above a crib.
