It shall be unlawful for any person to establish, maintain or operate a child-care facility for children, or to advertise or hold himself or herself out as being able to perform any of the services as defined in section 210.201, without having in effect a written license granted by the department of elementary and secondary education.

CONCLUSION SUMMARY

On July 25, 2022, Compliance Inspector (CI) Jessica Graham investigated the allegation that Jordan is not licensed. Jordan cares for thirteen children at a time. Children range from infant to eight years of age. This allegation is substantiated based following statute violation:

RSMo 210.211.1 which states: "It shall be unlawful for any person to establish, maintain or operate a child-care facility for children, or to advertise or hold himself or herself out as being able to perform any of the services as defined in section 210.201, without having in effect a written license granted by the department of health and senior services."

On July 25, 2022, Jordan Lasley, provider, was present with eleven children including two children age 1-year-old, four children age 4-years-old, four children age 3-years-old, one child age 4-years-old and one child age 5-years-old. An 8-year-old and 6-year-old were also present, who live in the home.

Ms. Jordan was not aware of needing to obtain a child care license but is going to submit an application with the department and work towards becoming licensed.

On August 8, 2022, CI Graham contacted the families via phone and they declined wanting any additional information mailed or emailed to them. Ms. Jordan did not have addresses for the children.

On September 20, 2022, CI Shelley Truesdale conducted an inspection and Jordan Lasley was present with only her child that lives in the home. Ms. Jordan is working to get licensed at this point.
