Until infants can hold a bottle comfortably, they shall be held by a caregiver during bottle feeding. Bottles shall not be propped.

CONCLUSION SUMMARY

Compliance Inspector (CI) Stephanie Spaulding investigated the allegation that a teacher propped an infant's bottle to feed instead of holding the infant and feeding him. The allegation is substantiated based on the following information:

5 CSR 25-500.202(2)(D) which states: "Until infants can hold a bottle comfortably, they shall be held by a caregiver during bottle feeding. Bottles shall not be propped."

On June 3, 2022, director Elayne Neal stated that Ms. Karrie was observed feeding four infant children and engaging with all of the children on June 1, 2022. Child A is 3-months-old and takes a long time to feed. Ms. Karrie put Child A on a boppy pillow and placed a small boppy on Child A's chest propping Child A's bottle.

On June 3, 2022, assistant director Emily Page stated that she was told about the incident of Child A's bottle being propped when she returned to the facility on June 2, 2022. She has watched the video footage from June 1, 2022, confirming that Child A's bottle was propped by Ms. Karrie. Ms. Karrie told her that propping Child A's bottle wasn't intentional, but she was feeding all four children at the same time.

On June 3, 2022, caregiver Karrie Left Hand stated that she was feeding several children at the same time and had been rotating holding the children to feed them on June 1, 2022. She did place Child A on a boppy pillow and propped Child A's bottle with a smaller boppy pillow.

On June 9, 2022, Parent A (parent of Child A) stated that she watched the cameras on June 1, 2022, when Child A was put on a boppy pillow and his bottle was propped using a smaller boppy pillow. She asked Ms. Karrie why Child A's bottle was propped and Ms. Karrie told her "because it takes a long time for Child A to finish the bottle and she didn't feel like holding it". Child A was in a corner, by himself, on the boppy pillow while Ms. Karrie was holding another baby.

On June 3, 2022, CI Spaulding observed video footage of June 1, 2022, with Ms. Karrie caring for four children. Child A was laying on a boppy pillow and then Ms. Karrie propped Child A's bottle.

The facility shall conduct a staff meeting to review all licensing rules and regulations as they pertain to propping infant bottles. The facility must provide the Office of Childhood with a statement, signed by all staff (paid employees and unpaid volunteers), to indicate they understand and agree to follow those rules and regulations.
