CONCLUSION SUMMARY

On October 30, 2018, CCFS Radney made an unannounced inspection to investigate this complaint. During the inspection interviews were conducted with Director; Lisa Hall, staff members: Christina Begay and Stephanie Handy, along with caregivers Elizabeth Skibo and Dawn Cook. During the interviews everyone admitted that Child A had been left alone outside on the playground while the caregivers and the rest of the children came inside. A phone interview was conducted with witness Ethel Johnson and in person interviews were conducted with Child A and Child A's mother. Based on the information presented and the time frames provided, it is estimated that Child A was left alone outside between two (2) and three (3) minutes. This report is substantiated for Licensure Rule Violations based on the information presented that Child A was left without adult supervision and unobserved on the playground on October 29, 2018 by caregivers Elizabeth Skibo and Dawn Cook.
