A copy of the form shall be given to the parent the day of the accident or injury and necessary explanations shall be given. The form shall be filed in the child's record. RSMo 210.254.2(5)

CONCLUSION SUMMARY

Section for Child Care Regulation has determined that Kids First has violated their disciplinary philosophy/policies that is listed on their Notice of Parental Responsibility (NPR). This was violated based on statements made by Jennifer Runyan, Child A and Child B that Angela Green drug Child A out from under the table. Kids First NPR discipline policy shows verbal warnings, take away privileges, notify parents and probation or dismissal. The current NPR does not allow for staff to place their hands on children or drag them as was done by Angela Green to Child A on May 24, 2019.
