CONCLUSION SUMMARY

Section for Child Care Regulation has determined this complaint to be substantiated. During the course of the investigation, Director Jan Krug, Assistant Director Nikki Wells, Child A's regular caregivers Lauren Rhoad and Cassie Glass, and Child A's mother were interviewed. All staff gave consistent statements regarding Child A being rough with other children and instigating the bites. They also gave consistent statements of having a plan in place to try to prevent further bites by addressing the issues that were causing the bites. Incident reports were completed for all three bites; however, parents were not notified immediately of all of the bites. Child A's mother stated that all of the bites occurred in the morning and they were not notified until pickup in the late afternoon. Director Jan Krug stated that Child A's father was informed of the bite at pickup on July 1st. The incident report indicated that the bite occurred at 7:40 a.m. that morning. Based on consistent statements by Director Jan Krug and Child A's mother that parents were not notified immediately of this bite, this complaint is substantiated.
