CONCLUSION SUMMARY

SCCR has determined that this complaint is substantiated based on interviews with Darcy Sanders, Nicole Bryan, and Lydia Pointer, staff members, Brittany Miller, facility director, and Jennifer Moss, facility owner, as well as observations made by CCFS Koetting.

Lydia Pointer, Darcy Sanders, Nicole Bryan, and Jennifer Moss all stated that that the facility at 1753 Southwest Boulevard closed on Monday, September 21, 2020 and had no children in attendance until Monday, September 28, 2020 at the 211 Oscar Drive location.

Brittany Miller stated that they told staff that they would begin accepting children for care again because they had received the compliance verification email from CCFS Koetting and assumed that they had passed. She knew they did not have their license at that point yet, but chose to open anyway.

Lydia Pointer and Nicole Bryan stated that Jennifer Moss and Brittany Miller told them that they would be opening for the children to come back on Monday, September 28, 2020. They told them that everything was done and they passed the state inspection, so they were good to start operating at the 211 Oscar Drive location.

Jennifer Moss stated that she was worried she would lose children if she remained closed until approved by SCCR, which is why she opened back up. She realizes now that she should have just dealt with that and waited to start operating. They told staff that they would begin accepting children for care again, even though they did not have their license yet.

On September 29, 2020, CCFS Koetting observed 46 children in attendance on the facility premises, as well as 10 staff members working. This allegation will be substantiated that Early Explorers Preschool, LLC was caring for children at 211 Oscar Drive, Jefferson City, MO without an approved license from the Section for Child Care Regulation on September 29, 2020.
