19 CSR 30-62.092 (1)(B)(2)(A)

An individually assigned crib, portable crib or playpen shall be provided and used for each infant and toddler. Stack cribs shall not be used.

19 CSR 30-62.092 (1)(B)(2)(G)

Cribs, portable cribs and playpens shall be free of soft objects, loose bedding or any object that can increase the risk of entrapment, suffocation or strangulation. Examples include bumper pads, pillows, quilts, comforters, sleep positioning devices, sheepskins, blankets, flat sheets, cloth diapers, bibs, pillow-like toys, wedges, infant positioners, special mattresses, special sleep surfaces, and other similar items.

CONCLUSION SUMMARY

SCCR has determined that Little Rascals Daycare and Pre-school is in violation the above listed licensing rules based on interviews with staff at Little Rascals Childcare and Preschool who stated that they have either observed blankets in the cribs of children under the age of twelve months or they have, themselves, allowed infants under the age of twelve months to fall asleep with a blanket in the crib. Further, one staff reported that she has seen an infant asleep on the floor of the facility.
