5 CSR 25-500.082(2)(B)2.B.(III)

If a unit for infants and toddlers is auxiliary to a facility for older children, centers initially licensed for infant/toddler care after the effective date of these rules or facilities adding new infant/toddler space, shall have play, sleeping and bathroom space in the infant and toddler unit. This space shall be separated from the space used for older children by floor-to-ceiling walls;

CONCLUSION SUMMARY

The Office of Childhood has determined that Adventures in Learning Childcare Center, L.L.C. was in violation of the above regulation. This determination is being based upon statements made by the director of the facility, Molly James, indicating that two one-year-olds, Child A and B, were being cared for in the 2-3 year old classroom. One of the teachers in the 2-3 year old classroom, Suella Miller, stated that two of the children in her classroom, Child A and B, are under 2 years of age. The other teacher in the 2-3 year old classroom, Courtney Thompson, stated that Child A and B are under 2 years of age, and that she takes them into the 3-5 year old classroom across the hall in the afternoons. The registered agent for Adventures in Learning Childcare Center, L.L.C., Nathan Martin, stated he was not aware that children under 2 years of age could be cared for outside of the infant-toddler unit as long as staff-to-child ratios were being maintained for them. During an inspection by Compliance Inspector, Jim Parsley, on September 16, 2021, Nathan Martin identified 2 children in the 2-3 year old classroom, Child A and B, as being under 2 years of age.
