### **CONCLUSION SUMMARY**

The Section for Child Care Regulation has determined the allegation is substantiated based on interviews with caregivers, Child A's parents, and observations of scratch marks on the sides of Child A's body and video surveillance of the incident. Caregivers, Delilah Reavis and Nadia Hendricks reported observing caregiver, Allyson Horst grab children by the arm and face leaving red marks on them. Director Diane Dickey reported Ms. Horst had her leg over Child A's body during the incident on November 13, 2020. Mrs. Dickey reported telling Ms. Horst to remove her leg from Child A. Ms. Horst reported during the incident Child A was moving around on the carpet during group time and she crossed Child A's arms around the front of her chest so Child A could not have access to her hands. Ms. Horst reported Child A had been self-harming. Child A's mother reported no one informed her of any self-harming or temper tantrums until November 13, 2020.

On November 16, 2020, CCFS Russell observed several small crescent shaped scratch marks on both sides of Child A's torso. CCFS Russell also observed the facility video surveillance footage from November 13, 2020, and observed caregiver, Allyson Horst in a power struggle with Child A from 9:04 a.m. to 9:17 a.m. For over thirteen (13) minutes Ms. Horst pulled, pushed, grabbed and restrained Child A. Child A was observed stomping her feet on the floor, kicking at the air and sliding her body down to the floor. At no time did CCFS Russell observed Child A engaged in self-harm that would cause crescent shaped injury consistent with finger nails.

SCCR determined the facility did not follow their current Notice of Parental Responsibility of use of "conscious discipline" or "no physical punishment" when caregiver Allyson Horst pulled, pushed, grabbed, and restrained Child A for over thirteen (13) minutes on November 13, 2020.
