CONCLUSION SUMMARY

The Section for Child Care Regulation has determined the rule violations occurred at Pearl Crescent Montessori, LLC. The parent reported hearing Ms. Nazanin Keshmiri threaten to put hand sanitizer in her child's mouth. The parent reported the incident to the managing member. Ms. Nazanin Keshmiri admitted to threatening to put hand sanitizer in the child's mouth. Ms. Nazanin Keshmiri reported she thought the parent would "give her a pass" since they were co workers. Omair Tariq investigated the incident when it occurred He required the staff to take an hour class on positive guidance. Ms. Nazanin Keshmiri also reported she failed to document incidents of the child biting and scratching. The director, Ms. Nazanin Keshmiri and the parent were all aware the child had bitten or scratched other children yet there were no incident reports. Ms. Nazanin Keshmiri reported she did not complete an incident report as she was trying to do the parent a favor. The parent reported she had been told about her child biting other children but she was not given incident reports.
