Child Care Facility Specialist (CCFS) Shari Copeland obtained a copy of the menu for the week of May 14, 2018 through May 18, 2018 which showed all food components for breakfast, lunch and snack to be following licensing rules. Then, Alecia Jones provided a copy of the menu for April 30th, 2018 through May 4th, 2018 and May 14th, 2018 through May 18th, 2018 which indicated that the proper food components were not being served for snack on Monday, April 30th, 2018 as pretzels and water were being served as well as on May 15th, 2018 when popcorn and water were to be served, on May 16 when popsicles and water were to be served and again on May 17th, 2018 when animal crackers and water were to be served. Therefore, this allegation is substantiated.
