CONCLUSION SUMMARY

SCCR determined the allegations of this complaint to be substantiated as a caregiver was found to be spraying children in the face with a water bottle, up to twenty children with one caregiver and no caregivers, and children leaving the room. In addition, Caregivers confirmed they take the children's stuffed animals away if they are not being good.

Surveillance tape of the classroom from May 6, 2021, showed children being sprayed in the face for fun and one child not taking it so well. In addition, the caregiver was observed on video grabbing a child by the arm and sitting her with force on the wall. Children were observed without caregivers in the room, leaving the room, and one caregiver leaving another with up to twenty children. The facility Notice of Parental Responsibility (NPR) was reviewed and was not being followed for their set child/ staff ratio and for their discipline methods.
