In case of an accident or injury to a child, the provider shall notify a parent immediately. If a child requires emergency medical care, a parent's prior written instructions shall be followed. A form shall be completed indicating the circumstances and the date and time of the injury. The form shall be signed by the caregiver and his/her supervisor. A copy of the form shall be given to the parent the day of the accident or injury and necessary explanations shall be given. The form shall be filed in the child's record.

CONCLUSION SUMMARY

SCCR determined that First Baptist Church Child Care violated this licensing rule. This is based on statements made by caregiver Jovonna Lopez who reported that Child A rubbed his back on a wall and got a scratch. She also reported that Child A stated another child scratched his hand but she didn't see it happen. She stated that Child A had red marks on his hand but no incident reports were filled out for these marks.

CCFS Romena Fox observed Child A's file and did not find any incident reports on file for the scratch on Child A's hand or scratch on his back. In addition, there was no documentation in Child A's file that the parent had been notified of these injuries.

All staff will read the license-exempt rules, focusing on 19 CSR 30-60.060 (11). A statement confirming that all staff have reviewed the rule shall be submitted to

SCCR with the staff's signature and date of review.
