19 CSR 30-62.192 (5)(A)

In case of accident or injury to a child, the provider shall notify the parent(s) immediately. If the child requires emergency medical care, the provider shall follow the parent(s) written instructions.

#### **CONCLUSION SUMMARY**

Section for Child Care Regulation has determined that the above licensing rule was violated. During the course of the investigation, Child Care Facility Specialist Jana Barton interviewed five staff, including Director Anna Olson. Consistent statements were made by all staff interviewed that Child A developed a red mark on his cheekbone during naptime. Several staff stated it resembled a rug burn, but no one knew for sure what caused the mark. No one reported seeing Child A be injured. An incident report was completed the day of the incident and was signed by staff and parent. The mark was noticed around noon but the parent was not notified until pickup. The complaint is substantiated based on failure to notify parent immediately of the red mark on Child A's face.
