# **RULE/STATUTE VIOLATION(S)**

## VIOLATION(S)

## 5 CSR 25-500.082(6)(A)3.

Adult supervision shall be provided at all times when children are outside. For children three (3) years of age and above, staff/child ratios may be one and one-half (1 1/2) times the indoor staff/child ratios. The required indoor staff/child ratios shall be maintained on the premises at all times.

#### 5 CSR 25-500.112(1)

The following staff/child ratios shall be maintained on the premises at all times:

#### 5 CSR 25-500.112(1)(A)

Birth Through Two (2) Years. Groups composed of mixed ages through two (2) years shall have no less than one (1) adult to four (4) children, with no more than eight (8) children in a group;

## 5 CSR 25-500.112(1)(B)

Age Two (2) Years. Groups composed solely of two (2) -year olds shall have no less than one (1) adult to eight (8) children, with no more than sixteen (16) children in a group;

### 5 CSR 25-500.112(1)(C)

Ages Three Through Four (3-4) Years. Groups composed solely of three (3) - and four (4) -year olds shall haveno less than one (1) adult to ten (10) children;

## **CONCLUSION SUMMARY**

The Office of Childhood has determined the allegation in this compliant to be substantiated . The determination is based on interviews conducted and observations observed during the course of the investigation.

Patricia Darvenstott stated in an interview the facility was out of ratio on November 24, 2021 due to substitute staff members calling in sick and regular staff members with scheduled days off. Ms. Darvenstott also stated on December 8, 2021 that two staff members had left the premises to take breaks. Ms. Darvenstott stated these two staff members were in a classroom with another staff member. Ms. Darvenstott stated when they returned from break other staff members would then take their break.

5 CSR 25-500.112 (1)(A): Birth through Two (2) Years. Groups composed of mixed ages through two (2) years shall have no less than one (1) adult to four (4) children, with no more than eight (8) children in a group.

This rule is substantiated due to an observation made by CI Trussell on November 24, 2021. During the initial walk through of the facility while investigating the allegation, CI Trussell observed the toddler room to have five children with one staff member.

5 CSR 25-500.112(1)(B) Ages Two (2) Years Groups composed solely of two (2) -year olds shall have no less than one (1) adult to eight (8) children, with no more than sixteen (16) children in a group

This rule is substantiated due to an observation made by CI Trussell on December 8, 2021. During the initial walk through of the facility, CI Trussell observed the two year old classroom to have 16 children with one staff member.

5 CSR 25-500.112(1)(C) Ages Three Through Four (3-4) Years. Groups composed solely of three (3) - and four (4) -year olds shall have no less than one (1) adult to ten (10) children.

This rule is substantiated due to an observation made by CI Trussell on November 24, 2021. During an initial walk through of the facility, CI Trussell observed one preschool classroom to have 13 children with one staff member. This rule was further violated when CI Trussell observed another preschool classroom with 19 children with one staff member. In addition, on December 8, 2021 when CI Trussell conducted an additional unannounced inspection, she observed one preschool classroom with 11 children with one staff member and an additional preschool classroom with 11 children and one staff member.

5 CSR 25-500.082(6)(A)3. Adult supervision shall be provided at all times when children are outside. For children three (3) years of age and above, staff/child ratios may be one and one-half (1 1/2) times the indoor staff/child ratios. The required indoor staff/child ratios shall be maintained on the premises at all times.

This rule was determined to be violated on November 24, 2021 when CI Trussell observed a preschool classroom with 19 children outside on the playground with one staff member. Ashley Scott stated to CI Trussell there was not another staff member that was supposed to be on the playground with her.
