Day care personnel shall be of good character and intent and shall be qualified to provide care conducive to the welfare of children.

CONCLUSION SUMMARY

On July 13, 2017, Anna Estopare (caregiver) was in the classroom with Alicia Pavelka (caregiver) when she saw Alicia grab Child A (2 years) by the ear and pull him to his seat at the table for not listening. Anna reported the incident to a coworker April Kovacs, who was also in the classroom when it occurred. April did not see Alicia pull Child A by the ear. Anna Estopare did not initially report the incident to anyone except for her coworker, April Kovacs.

On July 17, 2017, April Kovacs reported she was in the hallway with Alicia Pavelka and the class. The children were suppose to be sitting on a bench, but Child B (2 years) was not listening. Alicia walked towards Child B, yanked on Child B's ear telling him to listen, and then grabbed him by the hand and sat him down hard on the bench. April told Anna about Alicia yanking on Child B's ear and then sitting him down hard, and they decided to report the incident to Becky Moore, Site Director.
