# **RULE/STATUTE VIOLATION(S)**

RSMo 210.254.2(3)

The notice of parental responsibility shall include the following: The staff/child ratios for enrolled children under two years of age, for children ages two to four and for those five years of age and older as required by the department of health and senior services regulations in licensed facilities, the standard ratio of staff to number of children for each age level maintained in the exempt facility, and the total number of children to be enrolled by the facility.

#### **CONCLUSION SUMMARY**

Based on interviews with Tammy Olsen, teacher, Jaomi Craft, teacher, and Chris Waldmann, director, and observations by CCFS Koetting, the allegation referencing ratio violations will be substantiated due to sufficient evidence found that violates the facility's Notice of Parental Responsibility standard ratios. Upon arrival at the facility, CCFS Koetting observed the 3 year old classroom out of ratio by 5 children. Staff had no explanation for why the classroom was left out of ratio. CCFS Koetting also observed staff leave a child alone and unsupervised in the cafeteria while eating breakfast in order to help cover ratio in the 3 year old classroom. The child was left alone for about 1 minute.
