CONCLUSION SUMMARY

Based on interviews with caregivers and managing member, Andrew Ghassi of Apple of Your Eye Academy LLC, Child A was the past 4-5 hour timeframe of receiving a bottle as indicated on the Infant and Toddler Feeding and Care Plan provided to Apple of Your Eye Academy LLC by Parent A. Therefore, the following rule violation occurred:

19 CSR 30-62.202 (2)(B): The written diet plan for each infant/toddler shall be followed. The parent(s) shall update the plan according to the individual needs of the child until they grant permission in writing for the child to eat table foods.

Child A was dropped off at Apple of Your Eye Academy at approximately 8:30 am on August 2, 2019. Child A received a bottle at 10:48 am on August 2, 2019. Child A received jar food at 12:15 pm on August 2, 2019. Child A was picked up by Parent A at 4:16 pm on August 2, 2019.

Caregiver, Emily Farrow stated that Child A was not fussy and did not exhibit any indications of hunger all day.

LLC Managing Member, Andrew Ghassi stated that Child A was content in a jumper and began falling asleep at 4:15 pm on August 2, 2019 when a caregiver removed Child A from the jumper and put Child A in a crib. After being placed in the crib, Child A began to get fussy and Parent A came into the room to pick Child A up at 4:16 pm.

The Infant and Toddler Feeding and Care Plan for Child completed by Parent A indicates that Child A is to receive a six ounce bottle every 4-5 hours. Based on the timeline and video screenshots on August 2, 2019; Child A only received one bottle at 10:48 am and was picked up by Parent A at 4:16 pm.
