CONCLUSION SUMMARY

Compliance Inspector (CI) Jessica Glover conducted an investigation regarding the allegation that Child A (4-years-old) reported to Caregiver Whitney Huelskamp that he was grabbed by his neck from Caregiver Patricia McCarty. After conducting the investigation, CI Glover finds this allegation is substantiated. This conclusion is based on the following evidence of licensing rule violations which occurred at the facility:

5 CSR 25-500.182(1)(C)3. which states: "Only constructive, age-appropriate methods of discipline shall be used to help children develop self-control and assume responsibility for their own actions."

On March 21, 2022, CI Glover interviewed Director Josh Sharp who stated that Ms. McCarty was immediately put on administrative leave after learning that Child A stated she squished his face. Mr. Sharp stated there were previous issues with Ms. McCarty in regards to her tone of voice she used towards the children. Caregivers Katelyn Russell and Whitney Huelskamp stated they had concerns with the way Ms. McCarty spoke to the children as well. Ms. Huelskamp stated that Child A reported to her that Ms. McCarty squished his face. Ms. Russell stated that Child A reported to her that Ms. McCarty hurt his neck. Ms. Russell told Ms. Huelskamp to monitor children in the bathroom with Ms. McCarty to ensure children's safety. Ms. Huelskamp stated she and Learning Center Specialist Morgan Christensen had Child A demonstrate on Ms. Christensen how Ms. McCarty touched him, which he proceeded by squeezing her chin and neck. Ms. Huelskamp stated she observed redness on Child A's chin. Ms. Huelskamp also stated that Child A did not want to be near Ms. McCarty afterwards, which was not common behavior from him.

On March 21, 2022, CI Glover interviewed Parent A (Parent of Child A) who stated she never received an accident/injury report from the facility and did not receive a phone call until a day after the incident. Mr. Sharp stated an accident/injury report was not documented and he did not call Parent A until he received instructions from human resources to do so. Mr. Sharp stated he called Parent A on the evening of March 18, 2022, but stated the incident occurred on March 17, 2022.
