CONCLUSION SUMMARY

The Section for Child Care Regulation determined the allegation to be substantiated based on interviews with caregivers and observations from Child Care Facility Specialist (CCFS) Billie Russell. Caregivers, Lindsey Thorson, Dawn Owen and Lorie Lough, reported accident reports were visible on the front desk in the lobby of the facility. On September 23, 2019, CCFS Russell observed seven (7) accident reports on the facilities front lobby desk. The accident reports were face up and the forms could be seen in their entirety. CCFS Russell observed children's names and the accident/incident in which occurred for the form to have been filled out. These accident forms were on the front desk were parents sign children in/out and all persons enter/exit the building. Caregivers, Lindsey Thorson, Ashley Salyers and Dawn Owen reported Albert "Joe" Lough, caregiver/owner worked in the infant/toddler room on Tuesdays and Thursdays when caregiver, Ashley Salyers, went to school. Joe also helped in the school age classroom. Lorie Lough, caregiver/owner, reported Joe had all of the required paper work to count into ratio at the facility. On September 23, 2019, CCFS Russell observed Albert "Joe" Lough's personnel file. CCFS Russell observed and documented Joe Lough did not have a current comprehensive criminal background screening and eligibility letter on file.
