CONCLUSION SUMMARY

On February 28, 2023, the Office of Childhood (OOC) received an allegation that: Ameren UE posted on the building on 02/27/2023 that the facility will be disconnecting the Electrical service on 2/28/2023 at 3809 Louisiana Avenue, St. Louis, MO 63118 due to nonpayment. After conducting an investigation, Compliance Inspector (CI) Michelle Honea has found this allegation to be substantiated based on the following evidence:

5 CSR 25-500.032(4): which states; "The person(s) or legal entity who owns a childcare facility shall be responsible for meeting all debts and obligations incurred by the facility and for maintaining compliance with all licensing rules for group childcare homes and childcare centers."

On March 7, 2023, CI Honea conducted a phone interview with Birtha Lindsey who stated that the facility is not open for business and has not been in almost a year and has no children in care. The lights were turned off last Saturday, and turned back on Monday, due to an unpaid light bill. The light bill went to the wrong address. Ms. Lindsey has paid all past due payments and there will not be a problem going forward because all of the information has been updated.

On March 8, 2023, CI Honea contacted Ameren by phone to determine if the utilities have been paid. CI Honea spoke with the credit team and it was confirmed that Birtha Lindsey did have the service turned off for lack of payment but has since paid the bill and services were restored.
