### VIOLATION(S)

5 CSR 25-500.182(1)(C)11.

Children shall not be permitted to intimidate or harm others, harm themselves, or destroy property.

5 CSR 25-500.182(1)(C)3.

Only constructive, age-appropriate methods of discipline shall be used to help children develop self-control and assume responsibility for their own actions.

#### **CONCLUSION SUMMARY**

Compliance Inspector (CI) Stephanie Spaulding investigated the allegation that former employee Katie Brunk told a child to punch another child. The allegation is substantiated based on the following information:

5 CSR 25-500.182(1)(C)11. which states: "Children shall not be permitted to intimidate or harm others, harm themselves, or destroy property."

AND

5 CSR 25-500.182(1)(C)3. which states: "Only constructive, age-appropriate methods of discipline shall be used to help children develop self-control and assume responsibility for their own actions."

On June 7, 2022, director Emily Williams stated that Ms. Margaret "Grandma" told her about Ms. Katie telling a child to punch another child. Ms. Katie then resigned but she told Ms. Katie to not finish out her two weeks.

On June 7, 2022, caregiver Margaret "Grandma" Fulgham stated that Ms. Katie told a child that she hated him. Ms. Katie did tell a child to punch another child because they were spitting. The children did not hit each other and she and the director spoke to Ms. Katie about this incident.
