# VIOLATION(S)

5 CSR 25-500.192(5)(A)

In case of accident or injury to a child, the provider shall notify the parent(s) immediately. If the child requires emergency medical care, the provider shall follow the parent's(s') written instructions.

5 CSR 25-500.192(5)(B)

Information regarding the date and circumstance of any accident or injury shall be noted in the child's record.

5 CSR 25-500.102(1)(F)

Caregivers shall be capable of handling emergencies promptly and intelligently.

### **CONCLUSION SUMMARY**

The Office of Childhood determined the allegations of this complaint to be substantiated. The determination is based on documentation reviewed through the course of the investigation, observations made by Compliance Inspector (CI) Michelle Trussell and interviews conducted with the director Megan Murray and caregivers Hailea Cates and Katie Crippen.

Megan Murray stated she was not aware of the incident until Child A's grandmother contacted her and inquired about an accident report. Ms. Murray further stated when she contacted caregiver Katie Crippen about the accident and a report, Ms. Crippen admitted that she forgot to complete the report. Ms. Murray states caregivers can contact the office via walkie talkies or the center's Brightwheel application when they are outside and have an emergency.

Hailea Cates stated she was on the playground when the accident occurred but did not actually see Child A jump off the tunnel . Ms. Cates stated she saw Ms. Crippen check Child A's legs and did not see any visible injuries. Ms. Cates stated Child A was sitting by the bench and stayed there until his dad arrived to pick up from care. Ms. Cates stated she did not mention the accident to Child A's dad when he arrived to pick up Child A.

Katie Crippen stated Child A did not have any visible marks to indicate an injury after he jumped off the tunnel . Ms. Crippen stated she had Child A sit down to stay off his leg. Ms. Crippen stated she was present when Child A's dad picked him up from care but did not mention the accident to him. Ms. Crippen admitted she forgot to complete an accident report. Ms. Crippen stated she did not contact anyone immediately after the accident occurred.

CI Trussell observed the facility's emergency preparedness plan indicates for medical emergencies the parents will be notified immediately and the information regarding the circumstances will be documented and dated in the child's file.

The facility shall create a policy that ensures Accident/Injury reports are completed and kept confidential and protected from unauthorized examination.
