Groups composed of mixed ages of children two (2) years of age and older shall have no less than one (1) adult to ten (10) children with a maximum of four (4) two (2) -year olds. When there are more than four (4) two (2) -year olds in a mixed group, the staff/child ratio shall be no less than one (1) adult to eight (8) children.

CONCLUSION SUMMARY

On February 1, 2022, the Office of Childhood (OOC) received an allegation that Kids in Motion Learning Center LLC had one staff member present with twenty-seven children, violating ratio guidelines. After conducting an investigation, Compliance Inspector (CI) lan Fyfe has found this allegation to be substantiated based on the following evidence of licensing rule violations which occurred at the facility:

5 CSR 25-500.112(1)(E). which states: "Mixed Age Groups Two Years (2) and Up. Groups composed of mixed ages of children two (2) years of age and older shall have no less than one (1) adult to ten (10) children with a maximum of four (4) two (2) -year olds. When there are more than four (4) two (2) -year olds in a mixed group, the staff/child ratio shall be no less than one (1) adult to eight (8) children."

On February 8, 2022, CI Fyfe arrived at the facility and made contact with owner Kayun Jackson, as well as assistant director NeSena Jones. Upon arrival, Ms. Jones walked CI Fyfe to a room that had twenty-seven children present whose ages ranged from 2-years-old to 4-years-old; of those twenty-seven children, more than five were 2-years-old. Present with Ms. Jones was the only other staff member, Ms. Wanda Mitchell.

On February 8, 2022, CI Fyfe interviewed Owner Keyun Jackson. CI Fyfe informed Ms. Jackson that her facility was violating ratio guidelines. Ms. Jackson informed CI Fyfe that the ratio violation would be corrected after additional staff arrived in approximately one to two hours.

On March 1, 2022, CI Fyfe returned to the facility to conduct a follow up inspection and met with Assistant Director NeSena Jones. While at the facility, CI Fyfe observed each classroom to be in ratio.

The reporter was not interviewed due to the report being made anonymously to the OOC.
