CONCLUSION SUMMARY

Compliance Inspector (CI) Stephanie Spaulding conducted an unannounced investigation of the allegation that the facility is out of ratio. The allegation is substantiated based on the following information:

5 CSR 25-500.082(6)(B)2. which states: "Staff/child ratios for infant/toddlers and two (2) -year olds shall be maintained at all times."

AND

5 CSR 25-500.112(1) which states: "The following staff/child ratios shall be maintained on the premises at all times:"

5 CSR 25-500.112(1)(B) which states: "Age Two (2) Years. Groups composed solely of two (2) -year old's shall have no less than one (1) adult to eight (8) children, with no more than sixteen (16) children in a group;"

On November 8, 2021, CI Spaulding conducted a walkthrough of the facility to observe and document attendance and staff/child ratios. All classrooms were in ratio except the two's group that was on the playground. CI Spaulding observed seventeen children, all 2-years-old, with two caregivers.
